Madam/Sir,


A State Level Committee has been constituted under the Chairmanship of Justice P K Mohanty to review the progress of implementation of various waste management rules as per the orders of the Hon'ble National Green Tribunal (NGT), Principal Bench, New Delhi passed in the OA No.606/2018.

2. As per the decision taken in the State Level Committee, the Project Directors of District Urban Development Agencies of Bolangir, Cuttack, Dhenkanal, Ganjam, Keonjhar, Khurdha, Koraput, Mayurbhanja, Sambalpur, Sundargarh districts are nominated as **Nodal Officers** to oversee and coordinate the implementation of various waste management rules and compliance of the directions of Hon'ble NGT for **Urban areas** and Project Directors, District Rural Development Agencies of the above districts as the **Nodal Officers** for above purpose for the **Rural areas**.

Similarly, for remaining districts, the Project Directors of District Rural Development Agencies, who are officiating as Project Directors, DUDAs are nominated as **Nodal Officers** to oversee and coordinate the implementation of various waste management rules and compliance of the directions of Hon'ble NGT for both **Urban & Rural areas**.


